# Minutes of Tivetshall Parish Council Meeting: 7.30 p.m. Wednesday 9 November, 2016, Tivetshall Village Hall

#### 1. TO RECEIVE APOLOGIES FOR ABSENCE

Apologies received from Martin Wilby.

#### 2. TO CONSIDER APPLICANTS FOR CO-OPTION

Robert Alleguen-Porter was willing to be co-opted onto the Council. Rob introduced himself to Council and Council agreed that he join the Council. The acceptance of office was signed.

#### 4. MINUTES

The signing of the minutes was deferred to the end of the meeting.

#### 5. PUBLIC PARTICIPATION

A parishioner asked why broadband was not on the agenda when it had been said it would be and said that he was incredibly disappointed that it would not be discussed. The Chair apologised and said that time pressure on some Councillors had reduced the number of items on the agenda and that broadband would be on the next agenda. The parishioner pointed out that there was no meeting in December and the Chair said that may be not be the case this year.

A parishioner said that she was sorry that ClIr. Spratt was not present as she wanted to ask him about footpaths. New yellow signs are needed as the existing ones have faded. ClIr. Jollans said he would contact Gary Overland about fingerposts for footpaths and ask about yellow signs as well.

Cllr. Sadler say he was sorry that Cllr. Wilby was not present as he wanted to talk to him about the fingerpost renovation in his village.

#### 6. REPORT FROM CLERK AND COUNCILLORS

The Chair thanked Jo Cocks for her time on the Council and wished her all the best for the future.

#### 7. PLANNING

- 7.1. 2016/2475 Sunset, The Street. Alterations and an extension to dwelling. Council considered that this application should be approved.
- 7.2. 2016/2370 Alteration to existing storage at Thistledown Farm. The Clerk had not received any response to her application to an extension in time for this planning application and had been told that the alterations had already been done. In the circumstances Council felt that no comment was required.

#### 8. TO DISCUSS MAINTENANCE MATTERS

The Clerk informed Council that the cost for Norse to gang mow the playing field for 2017 was £1018. Council decided to proceed.

James Crerar had asked that Council consider cutting the grass before winter as it has been a long growing season. The cost for this was £150. Council agreed.
